# 5. Resolution for Change of Name of the Corporation to Naval Reserve Association of Canada /Association de la Réserve navale du Canada

Whereas the UNTDA has undergone structural changes including the expansion of its membership to all retired and active members of the naval reserve in Canada; and Whereas the name UNTD Association of Canada no longer reflects the inclusive nature of the Association's membership. The Board recommends to the membership that the name of the Association be changed from The UNTD Association of Canada / L' Association UNTD du Canada to the Naval Reserve Association of Canada / Association de la Réserve navale du Canada and that the By-Law #1 be amended accordingly, and application be made to Innovation Science and Economic Development Canada to amend our Articles of Incorporation accordingly.

The Citizen Sailors Virtual Cenotaph (CSVC) project has had a positive effect in raising the NRAC profile. Volunteers are still needed in further research. Bob White and John Dalziel have had major input into this project.

Peter Milson asked if new symbology is in progress. Graham Scott responded that this will be up to the new BOD to action.

Jennifer Bennett responded that there have been several attempts to revitalize leadership programs at the University of Alberta and Memorial University of Newfoundland. There has not been a great response from academia, however there still seems to be some interest in this approach.
